

# Prescribing Hints & Tips May 2025

### **CHANGE IN DOAC MONITORING RECOMMENDATION FREQUENCY**

NICE CKS guidance has changed from recommending at least 6 monthly monitoring of DOACs if the person is frail or older than 75 years to now recommending at least 4 monthly monitoring in this patient group. Nottinghamshire APC guidance for AF and DVT/PE will shortly be updated to reflect this change and OptimiseRx messages will be brought in line with the latest guidance.

Please note that the guidance advises more frequent monitoring in renal impairment or intercurrent illness that may impact renal or hepatic function.

### **NEW STANDARDISED ELECTRONIC DIRECTION TO ADMINISTER FORMS**

Standardised electronic forms will be replacing all the existing Direction to Administer forms across Nottingham and Nottinghamshire. These will be launched on the **9**<sup>th</sup> **June 2025**.

### **CAVERJECT® DISCONTINUATION**

Caverject® injection vials are being discontinued and replaced by the generic version: alprostadil injection vials 10mcg and 20mcg. **Please prescribe vials generically going forwards.** 

Alprostadil injections also come in pre-filled syringes (Caverject®Dual and Viridal® Duo) but these are currently experiencing supply problems. The administration method with pre-filled syringes is different to that of the vials, so if switching any patients from vial to pre-filled syringe, appropriate patient counselling and training is required.

### PATIENTS WITH A DOMICILIARY CARE PACKAGE – COMMUNICATION BETWEEN GP PRACTIES AND CARE PROVIDERS

If a patient has been identified as having a domiciliary care package provided by either the local authority or a private organisation, it is recommended that the GP practice correctly codes this in the patient's clinical record and establishes the number of visits per day the care provider will be attending the patient. This will enable the GP practice to review the patient's medication needs and help support the care provider to ensure medication is given as prescribed.

### **LEARNING FROM PATIENT SAFETY EVENTS (LFPSE)**

Please be reminded that as part of the 2025/26 GP Contract, practices are required to have regard to the <u>patient safety strategy</u> and also register for an administrator account with the learn from patient safety events service (LFPSE). This is for the purposes of:

- recording patient safety events at the practice about the services delivered by the practice, thereby contributing to the national NHS-wide data source to support learning, improvement and learning culture.
- enabling the practice to record patient safety events occurring in other health care settings (for instance if a GP practice wished to record an unsafe discharge from hospital).
- individuals recording patient safety events being able to download a copy of the record for purposes of supporting appraisal and revalidation.

## NOTTINGHAMSHIRE APPLIANCE MANAGEMENT SERVICE (NAMS) EXPLANDS TO INCLUDE CARE FOR PAEDIATRIC PATIENTS WITH A TRACHEOSTOMY OR LARYNGECTOMY

NAMS is a commissioned service providing care and prescribing for patients with a stoma. In 2023, the service was extended to include patients with a tracheostomy or laryngectomy (head and neck stoma), Initially, the head and neck service excluded those under 18 years of age (paediatric patients). We are pleased to announce that this service now **includes paediatric patients**. The **ICB Medicines Optimisation Team** will contact practices where they have identified eligible patients.
