Post Event Messaging Urgent Actions

An email has been sent to all Community Pharmacies in England outlining actions for community pharmacies to take regarding post event messaging (PEM). If you have not received this email, please check the junk folder and then get in touch with england.eastmidspharmacy@nhs.net requesting it is sent again.

ALL community pharmacies must check on PharmOutcomes whether there are any unactioned PEMs. Some pharmacies have already completed this work in July as part of a Midlands trial – if this applies to your pharmacy, please still check your PharmOutcomes system for further unactioned PEMs.

It is essential that you complete this work as there are patient safety risks, if for example a high blood pressure reading has not been followed up. In addition, sending PEMs to patients' GP practices is a requirement in most pharmacy clinical service specifications.

Required actions

- 1. Read the attached letter on the email, Annex 1 provides guidance on the priority order to review the clinical service notifications. For example, Priority 1 is post event messaging relating to the blood pressure service
- 2. Review and action the queue of notification emails within the PharmOutcomes system for the clinical services delivered by the pharmacy, in order of priority as set out in Annex 1.
- 3. Follow instructions for manipulating the suppressed post event messages (PEMs) held within PharmOutcomes as set out in the supporting documentation; and follow guidance for sending notifications to a GP practice where suppressed PEMs need to be sent.
- 4. If there are any concerns about potential patient harm because of delayed notifications following a pharmacy consultation, please report the incident using the 'Learning From Patient Safety Events' portal and use the code 'PharmacyPEM' for reporting purposes.
- 5. Pharmacists must consider and fulfil their duty of candour.

Early Prison Release

An email was sent to Community Pharmacies at the beginning of the month about early prison release. A summary of this information is below – please share with the whole Pharmacy Team.

The Electronic Prescription Service (EPS) is now being rolled out across the detained estate and contractors may see an increase in the presentation of non-nominated EPS prescription barcodes and / or FP10MDAs issued on discharge. These prescriptions will carry the following information on the front of the form:

- the letters 'HMP'
- prison name and address
- prison telephone switchboard number
- prescribing code

Patients presenting these prescriptions are exempt from prescription charges for this prescription form. To be exempt, their form must have 'HMP' printed in the prescriber address area on the front of the prescription form. In this instance a signature is not required on the back of the prescription form. This exemption in specific to this prescription form rather than the patient.

Shortages and Pricing Issues

Limited availability of some medicines can lead to significantly inflated prices. If this results in not being able to source a medicine at or below the reimbursement price in the Drug Tariff, please report the issue to Community Pharmacy England on this website page here; Report product over Drug Tariff price - Community Pharmacy England (cpe.org.uk) .Reporting in this way is necessary to bring the issue to the attention of the Department of Health and Social Care so that they can consider introducing a price concession. Community Pharmacy Technician Apprenticeship Training

NHS England Workforce, Training and Education (WT&E) have secured funding to support growth of the pharmacy technician workforce within community pharmacy by increasing pre-registration trainee pharmacy technician (PTPT) training capacity. Funding contributions are for new PTPTs that have not yet been enrolled or started PTPT training, with training placements to commence between November 2024 and 28 February 2025.
