Pharmacy First Update

There are a lot of changes happening in 2025/26 for the pharmacy first service. These include:

- £2 increase for Pharmacy First Minor Illness and Clinical Pathway consultations
- £7 increase for the oral contraception service
- Phased introduction of bundling requirements from June 2025
- Depression to be added to the New Medicines Service from October 2025
- Changes to the payments for hypertensive case finding -now £10 for opportunistic check and £50.85 for Ambulatory Blood Pressure Monitoring
- Emergency Hormonal contraception (EHC) to be including in the oral contraception service from October 2023, subject to IT infrastructure.

As emergency contraception will become part of the oral contraception service, (from October 25, IT allowing) you may wish to start getting ready for this. As well as the CPPE distance learning package, CPPE also have an online workshop on Tuesday 27th May 7-9pm. To book please visit the CPPE website on this link Emergency contraception: CPPE.

In the meantime, EHC is also commissioned by County and City Public Health teams. There are no plans to decommission the public health service in the short term as it is important that those that need this service can continue to access it, especially if there is a delay to the IT requirement. There may be a short period of time whilst both schemes run to prevent the gap in service. Please continue to sign up for the Public Health service using the following links.


Hypertensive case finding Promotion

Diabetes UK Free Type 2 Diabetes Prevention Online Module

Diabetes UK have launched their new **free** Type 2 Diabetes Prevention online learning module to equip professionals with the knowledge, skills, and confidence to support people to prevent or delay the onset of type 2 diabetes. We know that an estimated 6.4 million people are at increased risk of type 2 diabetes in the UK. For some people, this risk can be reduced by about 50% by getting support to eat healthy foods, be more active and lose weight, where appropriate.

Electronic Repeat Dispensing

The ICB are encouraging practices to use electronic repeat dispensing for suitable patients and have a guide for practices which can be read here; electronic-repeat-dispensing-full-guide.pdf. Community Pharmacy England does have some resources for Community Pharmacy which can be accessed here; Repeat Dispensing and eRD-Community Pharmacy England and includes the questions that should be asked before each supply.

Real Time Exemption Checking

Real Time Exemption Checking (RTEC) allows you to automatically check if your patients have a known exemption and can claim free NHS prescriptions. The technical solution enables your PMR system to digitally check and automatically apply an NHSBSA exemption or DWP benefit to your patient's electronic prescription. This means that there is reduced need to print off tokens saving the pharmacy time and money.

Specialist Medicines

Specialist medicines which should normally only be prescribed in secondary care settings are classified locally as "red drugs". These can be found on the Nottinghamshire formulary and if you would like to see an example please follow this link Nottinghamshire Area Prescribing Committee Formulary to view the entry for Abacivir.

The formulary is slightly different in the Bassetlaw area and this formulary can be viewed here Medicines and Products Directory Home

GP practices in Nottingham & Nottinghamshire have been advised to record drugs that should be prescribed by **specialists only** in a new way. This is to ensure that the clinical system can flag up safety warnings e.g. interactions, and that the drug appears on the patients' summary care record consistently.

Practices are now advised to enter the specialist drug in the usual repeat prescribing section, with the following wording in the directions field:

"HOSPITAL DRUG – DO NOT ISSUE / DISPENSE" and the quantity should be set to 1.

On SystmOne, other settings can be used to indicate that the script is not to be issued with the patients repeat medication, but these do not <u>prevent</u> the script being issued.



Recent ePACT data is showing that a small number of scripts are being inadvertently issued by practices and then dispensed by community pharmacy colleagues.

Please can we ask you to make all your staff aware that if such scripts are accidently issued, **these scripts should not be dispensed** – items can be endorsed as "Not Dispensed" and the practice should be notified.

Any scripts with unusual quantities (either low or high) should be queried with the practice to help prevent errors and promote patient safety.

Update on COVID-19 antivirals and lateral Flow tests

The following information has been taken from the NHS England Communication.

In response to the COVID-19 pandemic, the UK government procured and purchased COVID-19 antivirals to protect people who were at the highest risk of becoming seriously ill. This meant that they were available free of charge to NHS organisations.

As we have now moved out of pandemic arrangements, the Government are not procuring further supplies. This means that once existing centrally procured pandemic stockpiles exhaust or expire, COVID-19 antivirals will need to be procured and purchased by the NHS in the usual way - they will no longer be available free of charge to NHS organisations who instead will pay an agreed list price. The list price was considered by NICE when recommending these treatments as a cost-effective use of NHS resources.

Molnupiravir (Lagevrio®)

 Following expiry of the government stockpile, Lagevrio[®] is available for pharmacies to order directly from Alliance Healthcare at the list price from April 2025. Details can be found here: https://cpe.org.uk/our-news/expiry-of-government-stockpile-of-molnupiravir-lagevrio-200mg-capsules/.

Nirmatrelvir plus ritonavir (Paxlovid®)

- Government stockpiles of Paxlovid[®] will expire on 31st May 2025. The last delivery of Government stocks ordered by pharmacies will be 30th April 2025. The last order cut off times will be the standard cut off times for a delivery that day.
- We advise that pharmacies should continue to use up Government stock of Paxlovid® expiring in May that they have ordered. The last day pharmacies should dispense this stock is 24th May 2025, to ensure that the patient completes the 5-day course before it expires. Please dispose of expired stock in the usual manner.
- After government procured stock has expired, Paxlovid[®] will remain available for pharmacies to order directly from Pfizer via Alliance Healthcare from 1st May 2025.
- The company can be contacted directly for information: For product national reimbursement, access, or price related questions: <u>pfizerukaccess@pfizer.com</u> and for product supply related questions: <u>customer.services@pfizer.com</u>.

In both cases, the move to commercial supply will be through the usual essential service prescription dispensing and reimbursement processes.



NHS Lateral Flow Device Tests Supply Service extension

The community pharmacy NHS Lateral Flow Device (LFD) Tests Supply Service has been extended for another year, starting 1st April 2025.

This walk-in service provides at-risk patients eligible for COVID-19 treatments access to LFD tests for home use if they develop symptoms. A positive result helps inform clinical assessments to determine suitability for NICE-recommended treatments.

The full list of eligible patients is available in <u>NICE guidelines</u>, with more information available in the service specification.

Pharmacy Services Assistant Apprenticeship Consultation

Following changes in legislation and working practices the level 2 pharmacy services assistant apprenticeship standard which was approved back in 2018, may require changes. Research

Have you ever considered getting involved in Research?

We know that research benefits patients. Research is needed to improve health, advance patient care, develop new drugs and vaccines and more.
