#### Pharmacy First Update

As some of you will have seen, the advertising campaign from NHS England regarding Pharmacy First has restarted and hopefully you will see an increased uptake in this service. Nottingham ICB is also working with a number of GP practices to increase referrals and pharmacies near by may find they are contacted about numbers that they can manage for referrals.

The Specialist Pharmacy Service now have a Pharmacy First podcast series including expert speakers to debunk some of the clinical myths. The Specialist Pharmacy Service website also has a patient group directive section which you can access here <u>Patient Group Directions – SPS - Specialist Pharmacy</u> <u>Service – The first stop for professional medicines advice</u>. Patient Group Directives (PGD) are a legal mechanism to allow the supply of prescription only medicine without a prescription and hence it is important that all of the criteria in a PGD are adhered too, for example only providing medication to the age included in the PGD.

Community Pharmacy PCN Engagement leads

NHS England have provided some funding for Community Pharmacy PCN Engagement leads for 12 months.

In Nottingham we are planning for four leads to work in a place-based manner for approximately 15 hours a month, so one in City, one in the South, one in Mid Notts and one in Bassetlaw. Three have come into role as introduced below.



Ashton Craig from Reception Manager at Plains view surgery will be undertaking this function for the South Place.

Work continues to identify a Community Pharmacy PCN engagement lead in Mid Notts.

These leads will work within targeted areas to help with relationship building between GP practices and Community Pharmacies and work on uptake of Community Pharmacy, Pharmacy First services including the oral contraception service and hypertension case finding service.

#### Methotrexate Incident

We have been made aware of a recent "near miss" event in Nottinghamshire.

A script was issued by a GP practice for 10mg methotrexate tablets, the dose prescribed FOUR tablets to be taken once weekly which is over recommended maximum doses. This was then dispensed by a community pharmacy.

The intended dose was 10mg once weekly, the patient should have been prescribed FOUR 2.5mg tablets once weekly.

A background PCN safety search picked up the error and the patient was contacted prior to taking.



Following this we would like to take the opportunity to remind all colleagues that methotrexate is a high-risk drug so it is especially important to be checking and querying with the prescriber where appropriate, doses, frequency, (must **only be once a week** for non- cancer treatment) and relevant MHRA guidance. In addition, the Nottingham and Nottinghamshire Prescribing formulary stipulates that primary care prescribers should only be prescribing as **2.5mg tablets** to reduce the risk of overdose. If you are receiving prescriptions from GP practices or other primary care providers for 10mg tablets, please query with the prescriber. New City and County wide Sexual Health Service



Sexual Health Services Nottingham and Nottinghamshire (SHSNN) launched on 1<sup>st</sup> October 2024, bringing together services in the city and across the county, with the aim of delivering a more streamlined, consistent, and easily accessible service.

Nottingham University Hospitals NHS Trust (NUH) is delivering the service in partnership with Sherwood Forest Hospitals NHS Trust (SFHT), and supported by an online sexual health provider, Preventx.

The free and confidential service - funded and commissioned by Nottingham City and Nottinghamshire County Council's Public Health services - has a single, dedicated website and contact centre telephone number to help people to access services more easily. The number is 0300 131 7010.

The services offered have not changed, these include:

- Online testing via home testing kits
- Chlamydia Screening
- Contraception with a full range of methods
- Emergency Contraception
- Pregnancy Testing
- Free Condoms
- Sexual Health Advice

- Hepatitis Testing
- HIV Testing
- Pre-Exposure Prophylaxis (PrEP) to protect against HIV acquisition
- Counselling
- Relationships

#### Medication name change "Ralvo" to "lidocaine Grunethal"

There have been reports of patients struggling to obtain lidocaine patches following confusion due to a name change. The manufacturer has informed the ICB that "Ralvo" is now distributed and sold in the UK as "Lidocaine Grünenthal 700 mg medicated plaster. This is a name change only and does not affect the product supply, price, safety or licensed use.

The product is available via Alliance using the pipcode 1273861.
