Hypertensive Case Finding

Community Pharmacy teams have been busy checking people's blood pressure which is great news to help reduce undiagnosed blood pressure, a significant risk factor for cardiovascular problems.

There have however been concerns received from GP practices that not all Community Pharmacy Teams are offering Ambulatory Blood Pressure Monitoring (ABPM). Not offering this service increases the workload at the GP practice as the practice will have to check whether the blood pressure being raised was more than a one off, whereas the ABPM give that information.

Please be aware that as part of the specification, all Community Pharmacies offering this service must have an ABPM device. The information from the specification is below. The specification can be viewed via this link Advanced service specification: NHS community pharmacy hypertension case-finding advanced service (NHS) community pharmacy blood pressure check service)



"The pharmacy contractor must ensure they have both a blood pressure monitor and an ABPM device. The clinic blood pressure monitor and ABPM devices used must be listed on one of the following lists:

Area Prescribing Committee (APC) Website

The Nottingham and Nottinghamshire APC Website and formulary can help with some of the patient queries you may receive.

Recently there have been some queries about freestyle libre sensors which are defective or fallen off. The formulary website which can be viewed here; Nottinghamshire Area Prescribing Committee Formulary, has the following information;

"If any of the sensors are defective or fall off, the patient will need to contact the manufacturer to obtain a replacement. Patients should contact the Abbott Customer Careline, on 0800 170 1177, on the day or as close to the day that the FreeStyle Libre® falls off or is found to be defective".

The latest APC newsletter can be viewed here: <u>Area Prescribing Committee Bulletin</u> <u>February 2025</u> and keeping with the Freestyle libre theme has some information about the discontinuation of FreeStyle Libre ® 2 sensors as below

"Abbott Laboratories Ltd has taken the decision to phase out the FreeStyleLibre® 2 Sensors at the end of August 2025. This discontinuation does notimpact FreeStyle Libre® 2 Plus or FreeStyle Libre® 3 sensors. AbbottLaboratories has advised patients using the FreeStyle Libre® 2 Sensors tohave their prescriptions amended to the FreeStyle Libre® 2 Plus Sensors assoon as possible.

FreeStyle Libre® 2 Plus sensors are not interchangeable with FreeStyle Libre 3 Sensors which are only approved locally for use as part of a Hybrid Closed Loop System".
